

What Is the Anion Gap?

The anion gap is a derived value used to help evaluate acid-base status and electrolyte irregularity. It comes from routine blood chemistry and [Go here](#) measures the main reported cations and anions in the blood, especially **sodium** and **chloride**, along with **serum bicarbonate**. 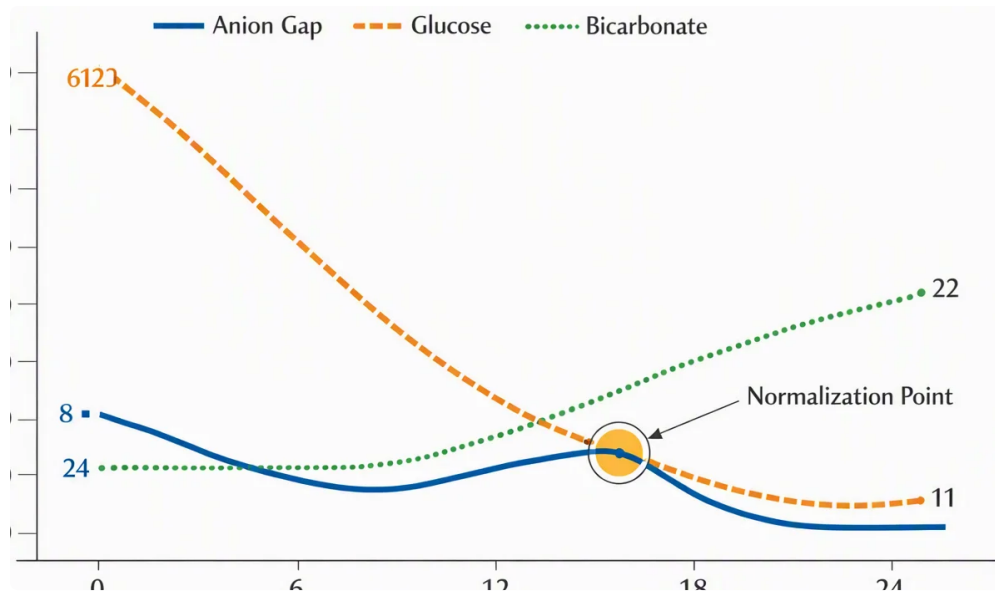
