

If an electrical injury happened at work in Georgia, several companies may share responsibility.

A site has an owner, a general contractor, the electrical sub, sometimes a utility, occasionally **car wreck claim lawyer** an equipment maker, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not stop a claim against another company that caused the danger.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
