

Fixing a 7-year-old washing machine depends heavily on parts availability and lead time realities. How do extended lead times for OEM parts shift the repair-versus-replace calculus?

Lead time is the hidden cost that makes or breaks a repair decision. A 7-year-old washer with a failed pump that requires an OEM part from a distant warehouse might face a two-week backorder. During that wait, you are either hand-washing clothes or paying for laundromat visits. At some point, the cumulative cost of waiting plus the repair charge exceeds the price of a new entry-level machine.
