- The heel touches the ground first with more force in a shortened window
- Because the heel is elevated, the foot's natural forward roll—particularly over the metatarsal heads—is compressed
- To maintain balance, you adopt a stiffer gait, often shortening stride length
- The ankle joint's range of motion is reduced as the calf muscles shorten, limiting natural dorsiflexion (upward foot flex)

Think of it as a rubber ball dropped on a hardwood floor versus a soft carpet: without the carpet's cushioning, more energy bounces back harshly.

Forefoot Load and Metatarsal Pain in Heels

When your heel is elevated, your weight shifts forward, increasing *forefoot load*. This means more pressure rests heavily on the metatarsal heads (the bones just behind your toes). This increased pressure can lead to:

- Metatarsalgia (pain under the ball of the foot)
- Development of calluses or corns
- Increased risk of stress fractures in the metatarsals over time
- Discomfort and fatigue that worsens with prolonged standing or walking

Toe Box Compression and Nerve Irritation

- Compress the toes together, which mechanically irritates nerves

Toe box compression not only limits breathability and comfort but contributes to altered gait patterns—you may unconsciously avoid fully pressing through toes to alleviate discomfort, leading to imbalanced walking.

Calf Shortening and Reduced Ankle Range of Motion

Your calves consist of two muscles: the gastrocnemius and the soleus. We often hear about calf stretches but tend to forget the soleus when it comes to heels and gait mechanics. When heels are consistently elevated:

- The calf muscles adopt a shortened position
- This tightness limits ankle dorsiflexion, an essential movement during walking and running
- The reduced ankle joint range of motion alters gait, requiring compensations higher in the kinetic chain (knees, hips, lower back)

Why does this matter? A stiff ankle reduces the foot's ability to properly roll through the stance phase, increasing impact forces and sometimes causing a “stomping” gait. Over time, this can contribute to discomfort or stiffness not only at the feet and ankles but also up the leg.

Posture Changes and Lower Back Stiffness

It may surprise you, but the effect of heel height is not confined to the feet and ankles. Changes in gait and shock absorption ripple upwards, influencing posture:

- Elevated heels shift your center of mass forward, encouraging an anterior pelvic tilt
- To compensate, your lower back arches more, increasing lumbar lordosis
- Muscle imbalances and stiffness can develop in the lower back and hips
- You might notice tension or soreness after wearing heels for extended periods
