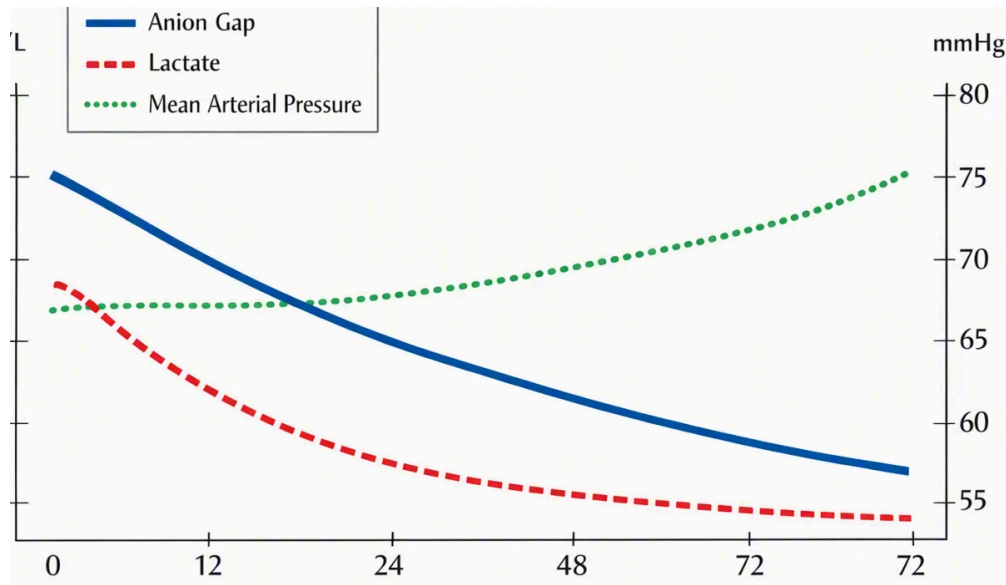


How the Anion Gap Measures
