

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

When the app is off, the driver is just a driver, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a [injury claims lawyer Atlanta](#) ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the records that prove it sit with the rideshare company, not with you.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
