

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, usually when the bills [car accident claim lawyer](#) arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Georgia law sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law [truck accident lawyer](#) also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, particularly where a commercial vehicle or a business is involved.
