

A truck wreck is not a car wreck. A loaded tractor trailer [atlanta personal injury attorney](#) can weigh many times what your car weighs, and the injuries are usually far worse.

The difference shows up immediately. The trucking company often sends its own people to the scene within hours, while you are still in the emergency room. They start protecting the company immediately.
