Commercial trucks also create records an ordinary car never does: electronic logging records, engine data, maintenance history, and the file the carrier keeps on the driver. A lot of it can be purged in the ordinary course of business, which is why a preservation demand usually goes out early.

## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
