

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, often when the bills arrive or an adjuster calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering **atlanta personal injury attorney** before death.

Georgia law sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.
