Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim involving a city, a county or a state agency can require written notice long before a lawsuit **Discover more** is due. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
