

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes <https://erickfzxc960.swiftnestly.com/posts/injury-attorney-serving-atlanta> first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
