- **Mandatory mediation**: legal imperative

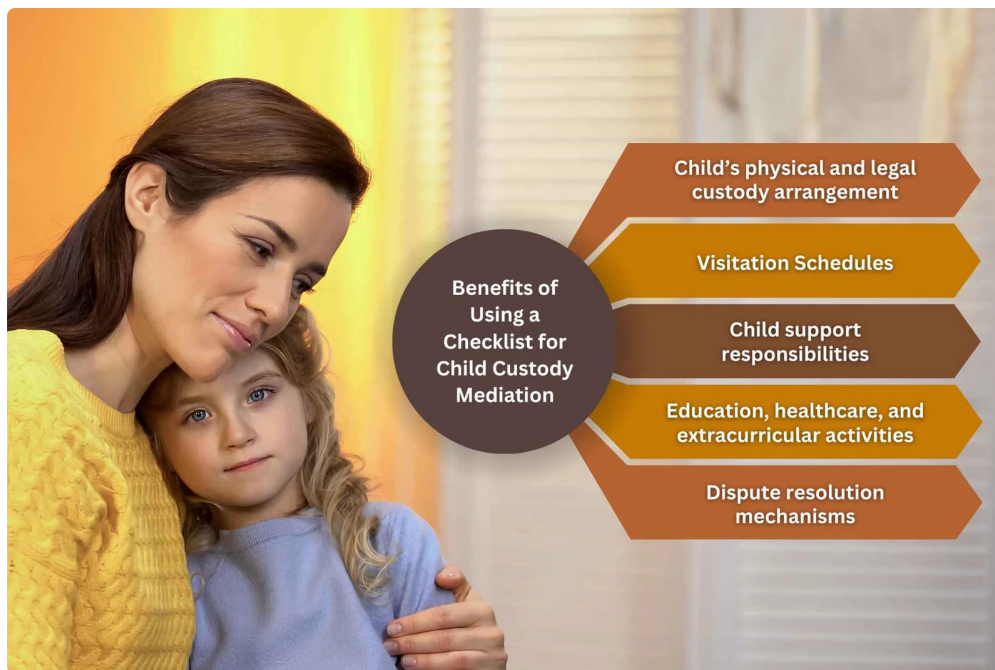
There is a legal disposition that imposes mediation before you go to court.
