

When a dog attack leaves someone hurt in Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia does not work that way. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

These records fade fast. Animal control files and recollections both fade, and the dog itself may [car accident injury lawyer](#) be gone before anyone captures what it had done before.
