

Understanding the Anion Gap?

The **anion gap** is a clinical calculation used to support assess **acid-base disorders** and identify patterns in **serum chemistry**. It compares the primary measured cations and anions in blood, mainly **sodium** and **chloride**, along with bicarbonate and sometimes potassium. This makes it a helpful tool for detecting an **electrolyte imbalance** that may not be obvious from a simple look at the lab panel.

$$\text{Anion gap} = \text{serum sodium} - (\text{serum chloride} + \text{serum bicarbonate})$$

Some clinicians include as well **potassium** in the equation, but the standard version leaves it out because potassium adds relatively little to the final value. When included, the formula becomes:

$$\text{Anion gap} = (\text{serum sodium} + \text{potassium}) - (\text{serum chloride} + \text{serum bicarbonate})$$

To use the calculation correctly, you need values from a **basic metabolic panel** or an equivalent **electrolyte panel**. The key inputs are **serum sodium**, **serum chloride**, and **serum bicarbonate**. A basic example helps show the math:

- Sodium: 140
- Chloride: 102
- Bicarbonate: 24

The anion gap would be $140 - (102 + 24) = 14$.

A commonly used **correction formula for albumin** includes a set amount to the measured gap for each reduction in albumin below normal. Different institutions may use slightly different versions, but the principle is the same: reduced albumin reduces the expected gap.
