

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some of them are shorter [atlanta personal injury attorney](#) than the general rule. A claim against a https://publishoryx.com/s/lcrb_ccvR4TNGorGR1CKi government entity can require written notice far sooner than the filing deadline. Evidence also thins out, especially when a company vehicle or a business is involved.
