

How the Anion Gap Measures

The **anion gap** is a calculated value that assists clinicians judge an **electrolyte imbalance** and refine the **differential diagnosis** of an **acid-base disorder**. It reviews major measured **serum electrolytes** to estimate the amount of **unmeasured anions** in the blood. 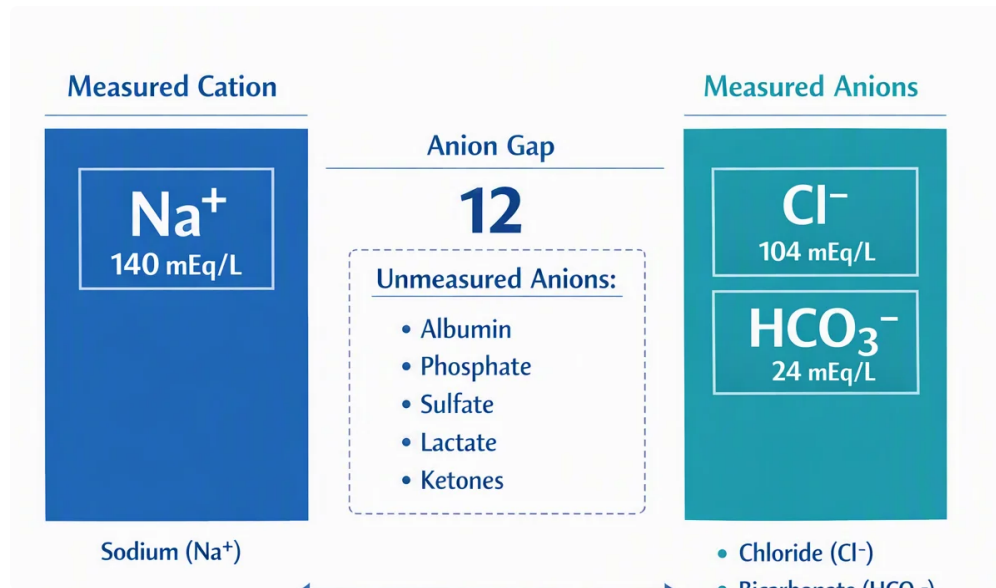

Anion Gap Formula and Reference Ranges

The common **anion gap formula** is:

Anion gap = sodium - (chloride + bicarbonate)



When potassium is included, the formula is written as:

Anion gap = sodium + potassium - (chloride + bicarbonate)

Because various laboratories and calculators may use different conventions, the **reference range** can change. That variability is one reason a reported result should always be interpreted based on the specific laboratory method and the patient's overall condition. A "normal" result on one system may differ slightly from another, so the **normal anion gap** is best understood as a method-dependent range rather than a single universal number.

Elevated Anion Gap Acid-Base Disorder Causes
