

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and their personal policy applies. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the records that prove it sit with the rideshare company, not with you.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
