

If you were riding and a driver did not see you in Atlanta, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: http://lotlab.net/index.php/Personal_Injury_Lawyer_in_Atlanta that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes it fits. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Scene measurements carry more weight than either version of events.

Severity helps and hurts. There is nothing around a rider, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
