

If an electrical injury happened at work around Atlanta, there is usually more than one responsible party.

A site has an owner, a general contractor, the electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

That third [18-wheeler accident attorney](#) party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
