

If you were hurt on a bus in Georgia, there is a clock most people never hear about.

The general Georgia deadline for injury suits is two years. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, and it has to be in the right form and go to the right place.

Missing that notice can end an otherwise strong case before it starts.

Ownership determines almost everything here. A public bus, a school bus and a private charter are three different cases. Ownership sets the notice requirement, the immunity analysis and the coverage available.

There is a second deadline nobody announces. A preservation letter sent late is a letter about footage that no longer exists.
