Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a [atlanta personal injury attorney](#) commercial vehicle or a business **Click for info** is involved.
