

How an anion gap calculator measures

An **anion gap calculator** is a clinical tool used to determine the disparity between the main measured **electrolytes** in a routine chemistry panel. It is typically calculated from **serum sodium**, **serum chloride**, and **serum bicarbonate** to assist in assessing **acid-base balance** and detect an **acid-base disorder**.
